



Environmental Management & Improvement – ISO 14001 General Policy Statement

The policy of Newline Logic Limited ('the Company'), trading as Daracore, is to develop, implement, maintain and improve an environmental management system compatible with the requirements of ISO 14001: 2004, and to maintain UKAS accredited certification to this internationally recognised environmental management system standard.

Our Company's primary environmental objective is that it should be seen and recognised as an environmentally conscious and responsible organisation, which makes a pro-active, positive impact on the environment which we all live and work in.

We have implemented an environmental management system which satisfies the requirements of ISO 14001:2015, and:

- A. Is appropriate to the nature, scale and environmental aspects and impacts of our activities, the products we use and the services we provide (so that it contributes to the overall viability of the of the organisation)
- B. Includes our commitment to assist in working towards a sustainable future, the protection of the environment, prevention of pollution and continual improvement of our environmental management system and environmental performance.
- C. Includes our commitment to comply with and where reasonably practicable to exceed the requirements of relevant / applicable environmental legislation and regulations and with other obligations to which the Company subscribes.
- D. Includes a commitment to continual improvement of environmental performance. This is achieved by setting annual environmental improvement objectives and targets which are regularly monitored and reviewed. The objectives and targets are publicised throughout the organisation and all staff are committed to their achievement.
- E. Is documented, implemented, maintained and communicated to all employees and by appropriate means, to all others who are or may be involved in or affected by our actions.
- F. Is available to the public.


The general environmental issues that we seek to address and the general approaches that we seek to adopt in implementing this policy, include:

- Reduction of waste and by-products, and reduction of resource consumption including use of energy, by applying best practice throughout everything we do.
- Prevention of polluting releases to the environment including emissions to air, releases to water, releases to land and energy related emissions e.g. heat, radiation, vibration.
- Where applicable, designing, developing and planning strategically, existing and new services for optimal performance whilst minimising any negative environmental impacts that may arise from their delivery.
- Controlling the environmental effects of raw material resourcing and our use of natural resources including the extraction and distribution of the same, and distribution, use and end-of-life of products used.
- Encouraging the protection of the environment and proliferation of appropriate types of wildlife and biodiversity.
- Ensuring that employees and other relevant Company representatives are trained to understand our environmental policy objectives and that they have the skills to implement it.
- Involving employees and all others including the local community, in Company related environmental matters.

It is important to our business and to our people that our serious approach to environmental improvement is recognised by our customers, the general public and our own employees and sub-contracted representatives including suppliers and all other organisations and people we from time to time work alongside and with whom we must co-operate to ensure the continued success of our business and projects.

This policy will be reviewed periodically to ensure its continuing suitability.
